Avoid dry sweeping, dust creation and wind dispersal.

Collect powder using a special dust vacuum cleaner with particle filter.

Transfer to a suitable labelled container for disposal according to local regulations.

If a vacuum system is not available only wet clean up methods should be used.

# 7.1 Precaution for safe handling

Avoid contact with skin, eyes and clothing. Avoid dust generation.

Put on appropriate personal protective equipment (see section 8). Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Workers should wash hands and face before eating, drinking and smoking.

The use of engineering measures such as local dust extraction is recommended to provide effective dust control in order to ensure compliance with the current Occupational Exposure Limits.
